***Resolution Urging the Governor of Virginia
And the Virginia General Assembly Pass a Clean Budget***

WHEREAS, each year the foremost duty of the Virginia General Assembly is to pass a budget or budget amendments that serve as Virginia's financial blueprint; and

WHEREAS, the Loudoun County Board of Supervisors is concerned that the Virginia General Assembly adjourned sine die on Saturday, March 8, 2014 without adopting a budget for the two year biennium beginning July 1, 2014; and

WHEREAS, several deadlines affecting Loudoun County are rapidly approaching including; every local government, must approve a budget and fix its tax rate by July 1 (VA. Code §§15.2-2500 and 15.2-2503); and, every locality is required by law to adopt its annual school budget by May 1, or at least 30 days after receiving an estimate of State aid whichever is later (VA. Code § 22.1-93); and, all local school divisions must notify its teachers of any reductions in force due to a decrease in the school budget within two weeks of approval of the school budget, but no later than June 1 (VA. Code § 22.1-304); and


NOW, THEREFORE, BE IT RESOLVED THAT, the Governor of Virginia and the Virginia General Assembly are urged to pass a budget as soon as practicable to ensure the continued functioning of state and local governments; and

BE IT FURTHER RESOLVED THAT, the Loudoun County Board of Supervisors respectfully request that the issue of Medicaid Expansion under the Affordable Care Act be decoupled from budget negotiations and considered in a separate legislative session to facilitate prompt passage of a state budget; and






